Ms. Sylvia Anzures Gonzales addressed the Council to update them on information requested from Mayor. The median income for Cibola County is \$41,000. She also stated the Municipal Judge hadn't had an increase in the last four years. She stated the Judge is on call 24 hours. Mr. Chris Baca with MainStreet stated that \$40,000 is the median income in Cibola County.

Motion: Councilor Lewis Second: Councilor Vasquez Ayes: 4 Nayes: 0 Mr. Kuipers stated that a neighborhood survey methodology needs to be proposed by April 6th. The surveys are due for submission by May 4<sup>th</sup>. The application deadline is June 22<sup>nd</sup>. They noted that a next phase on the Life-Long Learning Center might qualify for CDBG Economic Development funding. So they'd like the Council's blessing to just research this opportunity to see if it would work out. Ms. Jaramillo stated that Facility Build, who refurbished the main part of the Library, can do an estimate for us if given the parameters of what we want initially. There would be no charge for that initially, and they're hoping we would contract with them to do the construction. Ms. Jaramillo recognized Mr. Kuipers and our staff and Wilson & Company for all their hard work.

## **COMMENTS**

- City Manager Jaramillo stated the second Regular City Council Meeting will be scheduled for Tuesday, February 20, 2018 since Monday is President's Day. If we don't have very many items on the Agenda we will cancel the meeting. The Clerk will advertise the meeting as such.
- Ms. Jaramillo stated that they have been thinking about a new life for the old library. The Historic Society and the Mining Museum both approached her to put in an historic museum. She researched what costs are for operations in that building. Utilities run about \$7,500/yr. So, about \$10,000 a year would be a guesstimate. She'd like to offer it to let the Historic Society to develop it as an archive museum. The Mining Museum has additional displays and could work in partnership with the Historic Society. They would be in charge of their own staffing. We could offer \$10,000 in operations to keep that building open. The Quad has asked to use it for their registration the weekend of February 18. This Friday our staff will work on cleaning it up to make it available.
- Councilor Reynolds is concerned about getting her emails from the website and was assured these are forwarded to Council's personal email accounts when received by the City Clerk.
- Councilor Reynolds stated that she has been approached about crosswalks in the area of Mt. Taylor Elementary. Ms. Chris Roybal, MOC assured everyone when the temperatures warm up they will get that painted.
- Councilor Vasquez invited everyone to the Chamber Banquet and informed everyone one of our own Councilmen will be recognized. Mr. Lewis has done a great job in moving this town forward and has left his mark. Mayor Hicks congratulated Councilman Lewis and thanked him for everything he's done.
